Note:-

1. When D.B.I is not functioning urgent work of that Bench shall be listed before D.B.II and vice versa.
2. If for some reason, the cases assigned to D.B.I or D.B.II cannot be listed before that D.B. they shall be listed before the D.B.II and vice versa.
3. When one of the members of the D.B.I or D.B.II is not available Final Hearing old Criminal Appeals (whether or not already listed before a bench for that day), shall be listed before the available member.)

Provided that, if apart from one of the members of the D.B.I or D.B.II, one of the Single Benches is also not available, entire work of that bench shall be listed before the available member.


Provided further that, if apart from one of the members of D.B.I or D.B.II more than one of the Single Benches are also not available, only urgent work of those benches shall be listed before the available member of D.B.I or D.B.II as the case may be.

4. Subject to the provisions made in the note numbers 3, whenever a Hon'ble Judge is not available to sit in a Single Bench, urgent work of that bench shall be listed before the next available bench of the corresponding Roster, namely Criminal, Civil and Writ
